MAYOR TERMS OF OFFICE

- Lyman S. Parks - Elected as Commissioner Feb. 19, 1968 for a term from May 6, 1968 to Dec. 31, 1973. Appointed Mayor - Nov. 23, 1971. Effective Nov 26, 1971 - Sworn in Dec 7, 1971. Was then elected Nov, 1973 to fill out unexpired term until Dec, 1975.
- Abe L. Drasin - Elected Nov, 1975 to Mayor. Term through Dec, 1979. Re-elected Sept, 1979 for a term through Dec, 1983.
- Gerald R. Helmholdt - Elected Nov, 1983 for a term through Dec, 1987. Re-elected September, 1987 for a term through Dec, 1991.
- John H. Logie - Elected November, 1991. Term through Dec, 1995. Re-elected November, 1995 for a term through Dec, 1999. Re-elected 1999 for a term through Dec, 2003.
- George Heartwell - Elected September, 2003. Term through December 2011. Re-elected November 2011 for term through December 2015. Can no longer run for Mayor due to passing of November 2014 term limit proposal.
- Rosalynn Bliss - Elected in August 2015 Primary with 66% of the votes. Term through December 2019. Re-elected 2019 for a term through Dec, 2023.

William Johnson - Elected Nov, 1975 to replace Schwaiger. Term until December 31, 1979.

James Kozak - Elected November 3, 1981 to replace Heidenga. Term until Dec 31, 1985. Re-elected Nov, 1985 for a term through Dec, 1989. Re-elected Nov, 1989 for a term through Dec, 1993. Re-elected in Primary, Sept, 1993 for a term through Dec, 1997.

George Bowman - Elected in the Primary, September, 1979 to replace Johnson. Term through Dec, 1983. Re-elected Nov, 1983 for a term through Dec, 1987. Re-elected Nov, 1987 for a term through Dec, 1991.

Roy Schmidt - Elected in Sept Primary, 1991 - replaced Bowman. Term until December, 1995. Re-elected in September Primary, 1995. Term until December 31, 2007.

James Jendrasiak - Elected November 4, 1997 to replace Kozak. Term until December 31, 2005. Re-elected in November General 2005. Term until December 31, 2009.

Walt Gutowski - Elected November 2007 to replace Roy Schmidt. Term until December 31, 2011. Re-elected in November 2011. Term until December 31, 2015. Can no longer run for Commissioner due to passing of November 2014 term limit proposal.
