

# Online Application Economic Development Permit

**IMPORTANT NOTE:** You must register for a free Online Inspection Services account to be able to submit applications and make payments online.

To register, visit <https://inspections.grcity.us/citizenaccess> and click on “Register for an Account” in the upper-right corner of the screen. Registration only takes a minute and will allow you to access the full range of services available through the City’s Online Inspection Services portal. 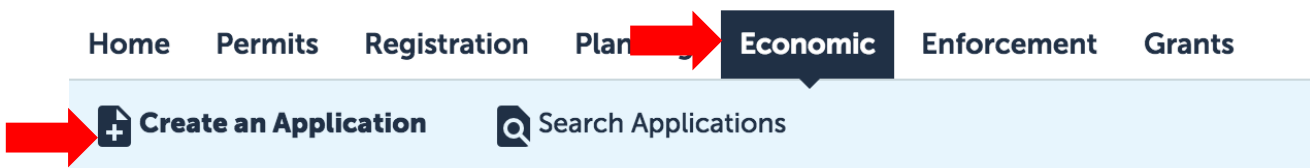
**BEFORE YOU BEGIN:** It may be helpful to complete the following documents in advance. You will need to attach them at the end of the online application.

Please note that each page has a two hour time limit for completion. If an application is left unattended for more than two hours, the entire application will be lost and will require recreation. At any time, you may click the orange “Save and Resume Later” at the bottom left of the page and your application will be saved. You may login at anytime to continue.

## Economic Development Office Brownfield Redevelopment Online Application Instructions

- 1) Navigate to: <https://inspections.grcity.us/citizenaccess/> in a web browser.
- 2) If you already have an account, Login to your account.
- 3) If you do not have an account, you must create an account, and then Login with your new username and password.
- 4) Click on the **Economic** tab at the top, and then **Create an Application** just below.



- 5) Read the Disclaimer of Warranty and Limitation of Liability. If you accept the terms, click the checkbox and then click **Continue Application**
- 6) Click **Economic Development Applications** to expand the list of available options.

- 8) Select the Property Qualification. Click **Yes** for the classification that matches the property, and select **No** for the remaining three. NOTE: You must attach documentation of property qualification at the end of the application.
- 9) Provide the Applicate Information.
- 10) Complete the address fields with as much information as possible, then click **Search**. Accela will identify the parcel and owner information. Verify this information is correct.
- a. If the project will take place on multiple parcels, click **Add a Row** and enter the additional parcel number(s) and address(es).

- 11) Provide the Applicant, Agent, and Taxpayer contact information. To auto-fill this information click **Select from Account**. Click **Continue**

- 16) Once all New Job Details are listed, click **Continue Application**
- 17) In the Attachments section, read through the list of documents and then click the checkbox for each item you will be attaching. Ensure you have all the required documents because you will need to upload them at the bottom of this page.
- 18) Read the statements in the Signature section, and initial after each statement. Then type your name in the last signature field.
- 19) To upload attachments, click **Add** and then browse for the files you wish to upload. Select the document type from the dropdown list. Once you have added all the documents, click **Save**. Then click **Continue Application**
- 20) Review the application, make any necessary revisions. Once you are satisfied with the application, click **Continue Application** to submit the application.

After your application has been submitted online, you will receive an email confirming submission. If you do not receive an email, call 616-456-3462 to confirm receipt of your application.

You can monitor the status of your application(s) by clicking on the **Economic** tab. Your application(s) will be displayed under **Records**. You can upload revised plans and other documents in the **Attachments** section of the record throughout the life cycle of the permit.
