(6) New Construction – Certificate of Compliance	\$175 per building
(7) Notice of Violation	\$265 per building plus \$100 per unit and/or \$40 per room
(8) Notice to Vacate	\$325 per building plus \$115 per unit and/or \$40 per room
(9) Inspection fee for every additional inspection, including but not limited to: court requested, attorney requested, progress inspection at request of owner/manager and/or Housing Appeal Board, Housing Rehab request	\$155 per building plus \$85 per unit \$45 per room
(10) Failure to keep appointment, arrange for inspection, or provide entry for scheduled inspection	\$120
(11) Occupied without a Certificate of Compliance or vacant unit under orders occupied prior to compliance approval inspection	\$380
(12) Administrative or Progress Extension	\$125
(13) Housing Appeal filed by last appeal date	\$120
Housing Appeal filed after last appeal date	\$170
(14) Ownership Research for any property not occupied by the property owner includes, but not limited to returned mail processing & lack of current registration	\$150
(15) Title Search	\$265 plus costs

(17) Issuance of Relocation Payment (plus relocation amount)	\$210 per unit plus costs
(18) Monitoring Fee for Vacant/Abandoned Structure and/or Prosecution Cases	No charge 0-60 days \$135 after 61-120 days \$260 after 121-180 days \$360 every 30 days after 180 days of no progress
(19) Notice to Repair or Demolish	\$370
(20) Demolition, per structure	\$425 plus vendor costs
(21) Contact Request	\$90
(22) Search Warrant	\$525 per unit or building
(23) Prosecution/Receivership Preparation	\$370 per case
(24) Recording document at Kent County Register of Deeds	\$90 plus costs
(25) Condemned for Human Occupancy	\$350 per building
(26) Collection Services Fee	<ul style="list-style-type: none"> • \$10.40 for the first past due invoice • 1% per month after due date • \$78 small claims filing fee
